- 2. RESERVATION: 100% of the rental is required to hold the reservation.
- 3. PAYMENTS are accepted in the form of cash, money order or check.
- 4. CANCELLATIONS: You will receive a full refund if you cancel 15 days before your rental term begins. You will forfeit all of your rent if you cancel within 15 days of your rental period and we cannot find another group to rent your rental period.
